Sub: Application for Letter of Permission for functioning of R.B.T.S. Govt. Homoeopathic Medical College, Ram Dayalu Nagar, P.O. Ramna, Muzaffarpur for 75 seats (including EWS seats) in Undergraduate (BHMS) course and 31 seats (including EWS seats) in Postgraduate Course [MD(Hom.)] for academic year 2023 - 24: reg.

Sir/Madam,

R.B.T.S. Govt. Homoeopathic Medical College, Muzaffarpur is functional since 2006 has submitted an application for permission for sanction of 75 seats in Undergraduate (BHMS) course and 31 seats in Postgraduate Course [MD(Hom.)] for the academic year 2023-24. The College has submitted the Part 1 information in which the entire functional profile has been narrated. MARBH has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under NCH Act 2020. As per 29(3) of NCH, Act 2020 your college was given an opportunity for being heard on the shortfalls intimated to them *via* hearing letter F.No.4-7/2023-24/NCH (MARBH) (104-01)/457 dated 20/07/2023.

MARBH has examined the submissions made by the College during physical hearing held on 03/08/2023 and the report of physical hearing was forwarded to the College vide letter dated 09/08/2023. The College is directed to maintain the essential standards to impart quality education in Homoeopathy and maintain the following measures in the Collegiate Hospital:

- (a) Case records should be maintained with demographic details of the patient such as name, age sex, address, phone number with complete case analysis, evaluation and repertorisation. These documents and follow up attendance of patients shall be made available in the medical record room for academic purposes of students.
- (b) Lab investigation reports should be maintained properly in case records.
- (c) Disease diagnosis shall be recorded in all case records as per ICD 11 criteria.

On perusal of the documents submitted by the College during physical hearing held on 25/07/2023 and report of Committee dated 25/07/2023, MARBH observed that the College is not fulfilling the required Faculties and Staff for Collegiate Hospital. Shortfalls persisting with he College was communicated to the College vide MARBH letter no. F. No.4-7/2023-24/NCH(MARBH)(122-11)/1136-1138 dated 08/08/2023. The above shortfalls observed in the College shall be rectified within a period of 30 days or before the first day of counselling for admissions whichever is earlier.

Considering the steps taken by the State Government for appointing the required faculties and staff for the Collegiate Hospital, and facilities available with the College, MARBH has decided to issue conditional permission to R.B.T.S. Govt. Homocopathic Medical College, Ram Dayalu Nagar, P.O. Ramna, Muzaffarpur for 75 seats (including EWS seats) in Undergraduate (BHMS) course and 31 seats (including EWS seats) in Postgraduate Course [MD(Hom.)] with Organon of Medicine (05 seats), Materia Medica (08 seats), Repertory (06 seats), Practice of Medicine (07 seats), Pharmacy (05 seats) for academic year 2023 - 24.

All admissions shall be made from NEET & AIAPGET qualified candidates only. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Govt. for All India Quota or the student admitted thereunder. The category wise list of the selected candidates may be informed to the MARBH after the process of admission is completed. Any admissions candidates may be informed to the MARBH after the process of admission is completed. Any admissions carried out other than NEET & AIAPGET qualified students will not be approved by MARBH.
