**Sub:** Application for letter of permission for functioning of R.B.T.S. Govt. Homoeopathic Medical College, Ram Dayalu Nagar, P.O. Ramna, Muzaffarpur – 842002 for continuing BHMS course with intake capacity of 75 seats including EWS and 31 seats for M.D (Hom.) in 05 subjects with 08 seats in Homoeopathic Materia Medica, 06 seats in Repertory, 05 seats in Homoeopathic Philosophy, 05 seats in Pharmacy and 07 seats in Practice of Medicine for the academic year 2024-2025- regarding.

R.B.T.S. Govt Homoeopathic Medical College, Muzaffarpur, is functional since 2006 and has applied for permission for continuing of BHMS course with intake capacity of 75 seats including EWS and 31 seats for M.D (Hom.) in 05 subjects with 08 seats in Homoeopathic Materia Medica, 06 seats in Repertory, 05 seats in Homoeopathic Philosophy, 05 seats in Pharmacy and 07 seats in Practice of Medicine for the academic year 2024-25. The College Part 1 information has been received for information on compliance to MSR 2013. The Medical Assessment and Rating Board has examined the profile of the College as to whether the college fulfils the Minimum Standards Requirements to be fulfilled as per the prevailing regulations under clause 28 of NCH Act 2020.

On careful examination of Part 1 information submitted by the college and hearing done on 11.06.2024, MARBH issued conditional permission for undergraduate course BHMS with intake capacity of 63 seats including EWS reduced from 75 seats and for PG course with intake capacity of 15 seats reduced from 31 seats in 05 subjects namely Homoeopathic Materia Medica 04 seats reduced from 08 seats, Repertory 03 seats reduced from 06 seats, Homoeopathic Philosophy 02 seats reduced from 05 seats, Pharmacy 02 seats reduced from 05 seats and Practice of Medicine 04 seats reduced from 07 seats for the academic year 2024-25. Thereafter college made 1st appeal to Commission on 11.07.2024 and Commission reiterated the decision of MARBH vide letter no. 30-5/2024-25/NCH-GR (15)/500 dated 30.09.2024.

The College made 2<sup>nd</sup> appeal to the Ministry on 03.10.2024. On the recommendation of the Ministry, MARBH has decided to issue Permission to R.B.T.S. Govt. Homoeopathic Medical College, Ram Dayalu Nagar, P.O. Ramna, Muzaffarpur – 842002 for continuing BHMS course with intake capacity 75 seats (including EWS seats) and 31 seats for M.D (Hom.) in 05 subjects with 08 seats in Homoeopathic Materia Medica, 06 seats in Repertory, 05 seats in Homoeopathic Philosophy, 05 seats in Pharmacy and 07 seats in Practice of Medicine for the academic year 2024-25.

It is further to mention that all admissions shall be made from NEET/AIAPGET qualified candidates only. It is further informed that minimum 15% of undergraduate seats and 15% of

postgraduate of the permitted intake capacity of UG seats and PG seats shall be treated as India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/UT govt as designated by Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/ AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to college can be withdrawn or denied in the subsequent year if college is found deficient in compliance to MSR 2013 anytime during the academic year.
